


William C. Moyers Saturday Night Banquet Speaker

- You have a car (outreach workers need to be able to transport themselves to look at rental properties, visit Oxford Houses and treatment facilities.)
- You would be able to promote Oxford House to treatment providers and other community organizations
- You are willing to work hard and want the most rewarding job in the world.

REMINDER - HOUSE EMAILS AND VACANCY UPDATES

The Oxford House system works when everyone pays attention and does their part. We all know that there are many people out there who could benefit from living in an Oxford House and we need to make sure we keep our vacancy lists accurate and up to date. Treatment centers and recovering individuals rely on this information they find on the website and, if it's not accurate, we all lose.

Please remember to go to the website and update your vacancy information regularly. Also, make sure that your house telephone information is correct. Most important, make sure that you answer the phone – or respond promptly to voice messages – about vacancies.

THE ANNUAL SURVEY OF OXFORD HOUSE RESIDENTS

All Oxford House residents are requested to complete a confidential Oxford House survey form once a year. This provides a "snapshot" of who lives in Oxford Houses while not intruding into the personal life of anyone. Honest answers help all of us to understand better the recovery process and the role that Oxford House living plays in that recovery.

Please encourage all residents of your Oxford House to complete a survey form during the month (or months) listed for your State's participation. House Comptrollers are responsible for encouraging all House residents to complete the survey during the appointed time. You may complete your own survey online or print out a hard copy of the survey and have another house member enter your answers on line.

Doing this survey well not only shows that "the inmates can run the asylum" but also that we are good at assembling data that will help the experts understand the process of recovery. Thanks in advance for following the schedule and for completing the survey. – Paul Molloy

2013 Survey Schedule: (This updates the schedule previously posted on the website and provides more time for those previously scheduled to begin in May, June and July))

April - June: North Carolina, Florida, Georgia, South Carolina, and Tennessee.

May - June: New York, New Jersey, Delaware, Pennsylvania and Ohio.

June - July: Maryland, DC, Virginia, West Virginia, Massachusetts and Vermont.

July - August: Washington, Louisiana, Wyoming, New Mexico and Colorado.

August: Oregon, California, Idaho, Texas and Iowa.

September: Missouri, Kansas, Indiana, Illinois and New Hampshire.

October: Oklahoma, Nebraska, Montana, Minnesota and Connecticut.

November: Mississippi, Maine, Michigan, Wisconsin and Utah.

February: Kentucky, Alabama, Arizona, South Dakota and North Dakota.

March: Arkansas, Alaska, Hawaii, Michigan and Vermont.

The Annual Survey helps make Oxford House the best in the addiction recovery field because the survey permits measurement of the recovery process and makes evaluation possible. Past surveys helped make the Oxford House Model a national best practice. Future surveys will continue to foster better understanding of the process of recovery.

State Conventions and Workshops

During April and May, a number of states had state conventions or workshops. In a way, a state convention or statewide workshop gives a small sample of the excitement and fun that comes from attending the annual World Convention. More than hundred residents and alumni gathered in Shreveport, LA where residents from all over the state shared their strength, experience and hope about recovery and the statewide network of Oxford Houses. An equal number of residents in New Jersey got together. At both events Oxford House leaders came from other parts of the country to join in. In June, the men and women of Oregon Oxford Houses get together and Washington State has its annual campout and statewide workshops.

Virginia and North Carolina both had conventions that followed the format of the World Convention. For all the residents and alumni, these state events make it even more exciting to come to the 15th Annual World Convention in Washington, DC over Labor Day Weekend.

All over the country, Oxford Houses are raising money to help pay the costs of getting to and participating in this year's convention. Hotel reservations need to be made soon to take advantage of the good room rate.

Our goal is to reach 750 attendees. Since there are now more than 12,000 recovery beds in the national network of Oxford Houses, that goal should be easy to reach.

All of us in recovery sometimes put off doing today that which we can do tomorrow. When it comes to getting a room and registering for the convention, we should not put it off. By the end of June everyone should have registered for the convention and reserved a hotel room.

This will be an important convention because it comes at a time when thousands more alcoholics, drug addicts and those with co-occurring mental illness will be able get primary treatment because of changes in health insurance. Will Oxford House be ready to "meet the need" for beds to assure long-term recovery? Yes, if enough people attend the convention to get up-to-date.

MOLLOY APPOINTED TO THE CSAT NATIONAL ADVISORY COUNCIL

Secretary Sibelius to a 3year term on the National Advisory Council for the Federal Center on Substance Abuse
Treatment. Molloy is cofounder and CEO of Oxford House, Inc.

The CSAT National Advisory Council meets several times a year to provide advice to Dr. Westley Clark, Director of CSAT, and his colleagues about how to improve treatment for alcoholics, drug addicts and those with co-occurring mental illness.

The theme of this year's convention, "Oxford House: Meeting The Need" has many meanings but for most it will mean that the organization has a long way to go to really 'meet the need' and change the culture of recovery. The Oxford House simplicity and effectiveness can make a difference in America. Far too many professionals doubt that 'the inmates can run the asylum' but for over 38 years, Oxford House has proven that they can. The self-help feature of Oxford House is its greatest strength but it is difficult for some to recognize this fact.

For 42 years the federal government has been pumping money to the states to combat alcoholism, drug addiction and co-occurring mental illness. Ninety percent of all those funds has gone to professionals – doctors, nurses and social workers. In recent years, judges and criminal justice professionals have been added recipients. Nevertheless, little progress has been made in reducing the Nation's alcohol and drug problems. Oxford House for 38 years has been demonstrating that it provides the living environment that permits recovering individuals to help each other to beat addiction. It has been meeting the need. Perhaps government and professionals should take greater notice of this fact.

The 2013 Convention is an opportunity to help everyone understand that Oxford House meets the need for most recovering individuals. Oxford Houses are cost-effective and they work. The nation needs more Oxford Houses – now.
