

Upcoming Outreach to Landlords

Ever since Oxford House began in 1975, landlords have played an important role in making Oxford House a success. Had landlords not been willing to rent their houses to groups of recovering individuals the Oxford House model would have quickly faded away. There were willing to do so however, and today there are 1,538 Oxford Houses.

As everyone in Oxford House knows, when a landlord rents a house to a group starting an Oxford House he or she is provided a copy of "Oxford House and Landlords," a document that is also available on our website under "Houses/Landlords."

Within the next few weeks, the central services office will send every landlord a letter to thank them for renting to an Oxford House and to remind them that they can help us monitor the charter conditions by letting us know if a group is getting off track. This in no way changes the absolute responsibility that each Oxford House group has to pay their rent on time and to operate their homes as prescribed in the Oxford House Manual[®].

Each house should let us know if they receive any feedback from their landlords. The purpose of the letter is simply to thank landlords and to strengthen the quality control that makes Oxford House the largest recovery home program in the world.

Oxford House: Good Neighbors – Good Citizens

This year's convention theme is "**Oxford House: Good Neighbors - Good Citizens.**" The convention will emphasize the importance of being good neighbors and good citizens both to promote successful recovery and to foster the acceptance of Oxford Houses in the broader community. Selected sessions will focus on how Oxford Houses have been good neighbors and good citizens traditionally and on ways by which they might become better ones.

In addition, general sessions and breakout groups will focus on particular aspects of Oxford House living, news in recovery research, sessions focusing on issues relating to reentry from incarceration, veterans' issues, medication concerns, Oxford House expansion domestically and internationally, and other timely and important issues. Speakers and panelists will include Oxford House residents and alumni and noted outside experts. The convention will also feature World Council elections and plenty of opportunity for socialization and networking.

The conventions provide a great opportunity for Oxford House residents, alumni and friends to come together to share ideas on successfully living in recovery. There will be many workshops and several social events. NAADAC-approved CEU credits are available for participation in the convention.

The registration fee for the convention for Oxford House residents and alumni is \$250 (until July 15), \$275 (after July 15) or \$350 at the door. The fee for all other participants is \$450. The fee covers all general sessions and breakout sessions, coffee breaks, the Friday night get-together and the Saturday dinner.

Oxford House Modernizes Research

Oxford House has led the way in encouraging meaningful research to understand and improve the odds of recovery without relapse. In a recent book, Jeffrey D. Roth, MD, Board Certified in Addiction Psychiatry, wrote:

While research on AA has been limited by the role of anonymity in recovery, the willingness of Oxford Houses to open their doors to academic research gives us an opportunity to see recovery from addiction in action.¹

Not only has Oxford House encouraged residents and alumni to co-operate with academic researchers but it also conducts annual surveys to establish a profile of residents on the road to long-term recovery.

To make this effort even more effective, World Services is developing a research tool that will use "Survey Monkey", an electronic data collection technology. In the near future, each house will be able to input survey responses online. The House Comptroller will be given the job of encouraging everyone to respond. The new approach will make it much easier to analyze the data and for Oxford House to continue to be the organization that continues to develop the best evidence of how recovery works and how Oxford House living increases the odds of staying clean and sober forever.
